Sealed Bids: Sealed bids for the construction of the project titled: **FY 2019 CDBG for Sanitary Sewer System Improvements** for **The City of Pelham, Georgia**, will be received until **11:00 A.M.** on **Tuesday, July 28, 2020** at the **Pelham City Hall, 108 Hand Ave. W., Pelham, GA 31779** at which time and place all Bids will be publicly opened and read. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.

Contractor License: Any Contractor submitting a bid must be a Georgia Licensed Utility Contractor. License numbers must be written on the face of the bid envelope. No bid will be opened unless it contains the Contractor's Utility Contractor license number. See Instructions to Bidders for additional bidding requirements.

Work to Be Done: The work to be done shall consist of furnishing all labor, materials and equipment necessary to construct the proposed **FY 2019 CDBG for Sanitary Sewer System Improvements** as shown on the construction drawings. In general, construction consists of $\pm 8,500$ L.F. of Cured-In-Place-Pipe sewer main rehabilitation, ± 190 V.F. of manhole rehabilitation, sewer service replacement and all associated measures for the complete project. This work will be awarded in one (1) contract with a **180** consecutive calendar day construction schedule.

Bonds: All bid forms must be accompanied by a Bid Bond in an amount not less than ten percent (10%) of the amount bid. The successful bidder, if awarded the Contract, will be required to furnish a Performance Bond and Payment Bond, each in the amount of one hundred percent (100%) of the Contract amount. All bonds must appear on the Treasury Department's most current Circular 570 Listing.
