- The park is for skateboarding/inline only. All other uses are prohibited.
- o All Skaters must have a liability waiver on file (Skaters under 18 years of age, parent/guardian must sign release forms in person or have forms notarized.)
- All Skaters must be a minimum of 6 years of age.
- ALL SKATERS MUST WEAR THE APPROPRIATE SAFETY GEAR, WHICH INCLUDES: HELMET, ELBOW PADS, AND KNEE PADS. (FAILURE TO WEAR SAFETY EQUIPMENT MAY RESULT IN LOSS OF PARK PRIVILEGE.)
- All food, drink, smoking and chewing gum/tobacco are prohibited on the pad.
- Profanity and abusive language are prohibited.
- o All Skaters must skate safely at all times.
- All Skaters must avoid collisions with others.
- Fighting or other disruptive behavior is prohibited.
- All equipment used by skaters must be in good condition and not damage the park or its structure.
- Spectators are not permitted on the pad.
- Notify City Hall of any unsafe conditions found inside or outside the park.
- o No contests of any sort are allowed in the park unless approved by the City Manager.
- No trespassing while facility is closed for business.
- All forms of graffiti, tagging or other means of defacing City property is strictly prohibited. (Such activities may result in closure of the facility until it can be cleaned/repaired, expulsion from the park, and action taken by the Pelham Police Department.)
