PUBLIC HEARING-COMMUNITY DEVELOPMENT GRANT

The City of Pelham is considering applying to the Georgia Department of Community Affairs for a Small Cities Community Development Block Grant of up to \$500,000. The funds must be used to benefit low-and moderate-income persons. The activities for which these funds may be used are in the areas of housing, public facilities, and economic development. The purpose of this hearing will be to obtain citizens input into the development of the application. City Manager Hedges outlined the scope of work, target area, project cost, and funding sources. With no one from the general public to speak Council Member Parrish made a motion to close the Public Hearing, seconded by Council Member Johnson. Mayor Eubanks declared the Public Hearing closed at 6:35 p.m.

With a quorum present, Mayor Eubanks called the meeting to order at 6:35 p.m. followed by the Pledge of Allegiance to the flag. Council Member Robinson provided the opening prayer.

Jim Hedges reported the following: Donnie Cochran Community Complex the inmate crew from the State Department of Corrections will remove the wire from around the entire complex. On March 17, 2014 the City of Pelham became the 9th city in Georgia to be recognized as a Purple Heart City. In January signs were ordered and installed displaying Pelham as a Purple Heart City.
