MINUTES FROM PRIOR MEETING

Council Member Parrish made a motion to approve minutes from the September 20, 2018 Regular Council Meeting, and October 11, 2018 Called Council00 Meeting as presented, **seconded by Council Member Johnson. The vote was unanimous.**

CHAMBER OF COMMERCE REPORT

Chamber Director Caitlyn Hatcher reported on the following: .

July events included: GACCE Annual Convention-Jekyll, Book signing at Library-TM Brown a book about Pelham, Back to School Bash-Freedom Park, Back to School Convocation, and IDP Meeting-retail Space HTC.

August events included: Ribbon Cutting-Pelham High School Field House, Regional Chamber Meeting-Thomasville, Young Gamechangers Graduation and Final Presentation, State Superintendent-Book Delivery, South Region AG Meeting-PCS, spoke at Camilla Kiwanis meeting to update them on Pelham, Ground Breaking for Southeast AG, Began Locate South Georgia LEADS, and Pelham City Schools Community Work Session.

September events included: Wildlife Auction, National Chamber Week, Locate South Georgia LEADS, and Youth Leadership Initial Meeting.

MAIN STREET REPORT

Main Street Director Alyssa Blakley reported of the following:

Projects include: Downtown Streetscape-Flowers will be rotated out to fall/winter flowers into the adopted beds. Pending debris removal by the city form Hurricane Michael. Downtown Murals-Awarded \$5,000 for a 2nd mural downtown by Georgia Council for the Arts.

Community Development includes the following: Collingsworth Park-Fencing will be replaced, Kahn Park-Trees pruned, Francis Davis Park-Mitchell Co. Recreation reconditioning baseball diamond, estimates haven been given on repairing the fence, Beautification Enhancement Program (GDOT Grant) \$29,200- Awarded in July 2018 will supply landscaping to the U.S. 19 and HWY 93 corridor connecting to the T-project on East Rail Road Street.

Downton Development Authority reports include: "Hotdog Stand" has been rented to Lola Brinkley opening pending remodel of drive thru window, Old Pelham Hotel-Working with DCA Design Team who will provide a conceptual rehabilitation drawing of the building for marketing.

DEPARTMENT REPORTS

Reviewed department reports from Pelham Police Department, Municipal Court, Fire Department, and Code Enforcement.

CITY MANAGERS REPORT

City Manager Craig Bennett reported on the following: Since Hurricane Michael all of the city water utilities are back up with a few exceptions, the boiling water advisor has been rescinded, the electricity has been restored for the citizens that are connected to Georgia Power with a few exceptions to some homes, FEMA will be coming and Mitchell County has been deemed a Public Assistance County on Sunday night and on Tuesday night it was designated as an Individual Assistance. You can register with FEMA online at www.disasterassistance.gov. City Hall during normal business hours will have a computer available for citizens to come in and do their application for FEMA online. Storm debris can be left on the curb or the right way natural debris

should be separated from manmade debris. Citizens will also be allowed to take the debris to the dump site behind the Farmers Market which has been established as a temporary dump site for natural debris. The city had up to 15% of property damaged during the storm with the most noticeable being the roof at the depot which is 80% gone which has caused some water damage inside. Also had damage to the roof on the Hand Building, parks and cemeteries are not covered under the current insurance. The curfew was modified from 12 midnight until 6 a.m. Commended the efforts of the Police Force, Fire Force, Utilities and Public Works.

EXECUTIVE SESSION

Council Member Johnson made a motion to close Regular Session and enter Executive Session for Legal Litigation, seconded by Council Member Hatcher. Mayor Eubanks declared the meeting closed at 7:10 p.m. for the discussion of Legal Litigation.

Council Member Johnson made a motion to come out of Executive Session and Reconvene Regular Session, seconded by Council Member Parrish. Mayor Eubanks declared the Regular Session was back in session at 7:23 p.m.


